Mayor Brown called the regular meeting of the City Council to order. Present were Council Ashworth, Hazlett, Zoellner, Clerk Blevins, Administrator White, and Attorney Stretesky with Wahrer being absent.

#### **CITY ADMINISTRATOR REPORT:**

Administrator White stated the city is installing T1 lines in all the city buildings. We have had some technical issues but they should not interfere with any services provided by the city. Jim Wear of the Salute to American Veterans Rally Committee presented the Council an award for their support and dedication to this event. Wear also stated the Toys for Tots event will be held on December 14, 2011.

### **FINANCE DIRECTOR REPORT:**

Finance Director Harris gave the council an update of the device counts in the City for the 4<sup>th</sup> quarter device fees. We are down 45 machines mostly due to Gold Creek and The Wildwood removing several machines. Harris will be in Denver tomorrow for the Gaming Commission hearings.

### PLANNING & HISTORIC PRESERVATION REPORT:

Development Director Manning stated the Elks sign is back up and we are still working on the Cottage Inn sign. The painting on the Virgin Mule should be complete soon. There has been an old water tank moved to the Heritage Center and there are designs and plans to place it on a permanent stand.

Development Director Manning stated the applicant is requesting approval of three signs #1 front façade (south): allow internally lit, allow 144 sq ft where 58 sq ft required; #2 side façade (west), allow internally lit, allow 144 sq ft where 29 sq ft is required; #3 freestanding on the corner, allow internally lit allow 70 sq ft where

The proposed setback is 5 feet. There was no public comment. Motion by Ashworth to approve the Rear Yard Setback at 347 W. Carr Avenue Second by Hazlett and motion carried.

#### **PUBLIC COMMENT:**

Bill Miller of Woodland Park introduced himself to the Council and stated he is a candidate for Teller County Commissioner for District 3. Miller stated he looks forward to working with the Council in the future. Jane Mannon CCV Gold Mine gave the Council an update of some of the activities they may see going on at the mine. Mannon stated the mine hopes to do some seeding between Cripple Creek and Victor this fall along HWY 67. There may be some activity on the mountain above Cripple Creek around the Hoosier head frame the hoist house is collapsing. The mine will try to salvage as much as possible but not sure this can happen.
