
Subject: First Quarter Device Count

The device count for the first quarter of 2024 is 3,031, which is an increase of 223 devices, or 7.9%, from the fourth quarter of 2023. It is great to see the device count go above 3,000 again. The Chamonix property opened with 228 machines. The final page of this report shows which casinos added/removed machines. Recall that 2020, when the Pandemic started, marked the first time the city has been below the 3,500 threshold. Comparing the first quarter 2024 device count to the pre-Covid device count for the first quarter of 2020 of 3,585, the city is still down 554 machines, or 15.5%.

The following chart shows the long-term trend of the number of devices in town.



If you compare the first quarter of 2024 with the first quarter of 2023, the number of devices is up by 208 machines, or 7.4%. The following table compares 2024 and 2023 by quarter and contains information for prior years.

If you compare the first quarter of 2024 (3,031) with the high point the city reached in the third quarter of 2008 (5,170) when the Wildwood opened, the number of devices is down by 2,139 machines, or 41%.

Comparing the actual number of devices to those budgeted for 2024; the city is down 36 machines year-to-date. I am hopeful that Full House Resorts — Chamonix will add additional machines when they are fully opened. The following table compares the actual number of devices for the quarter to the budgeted figure.
